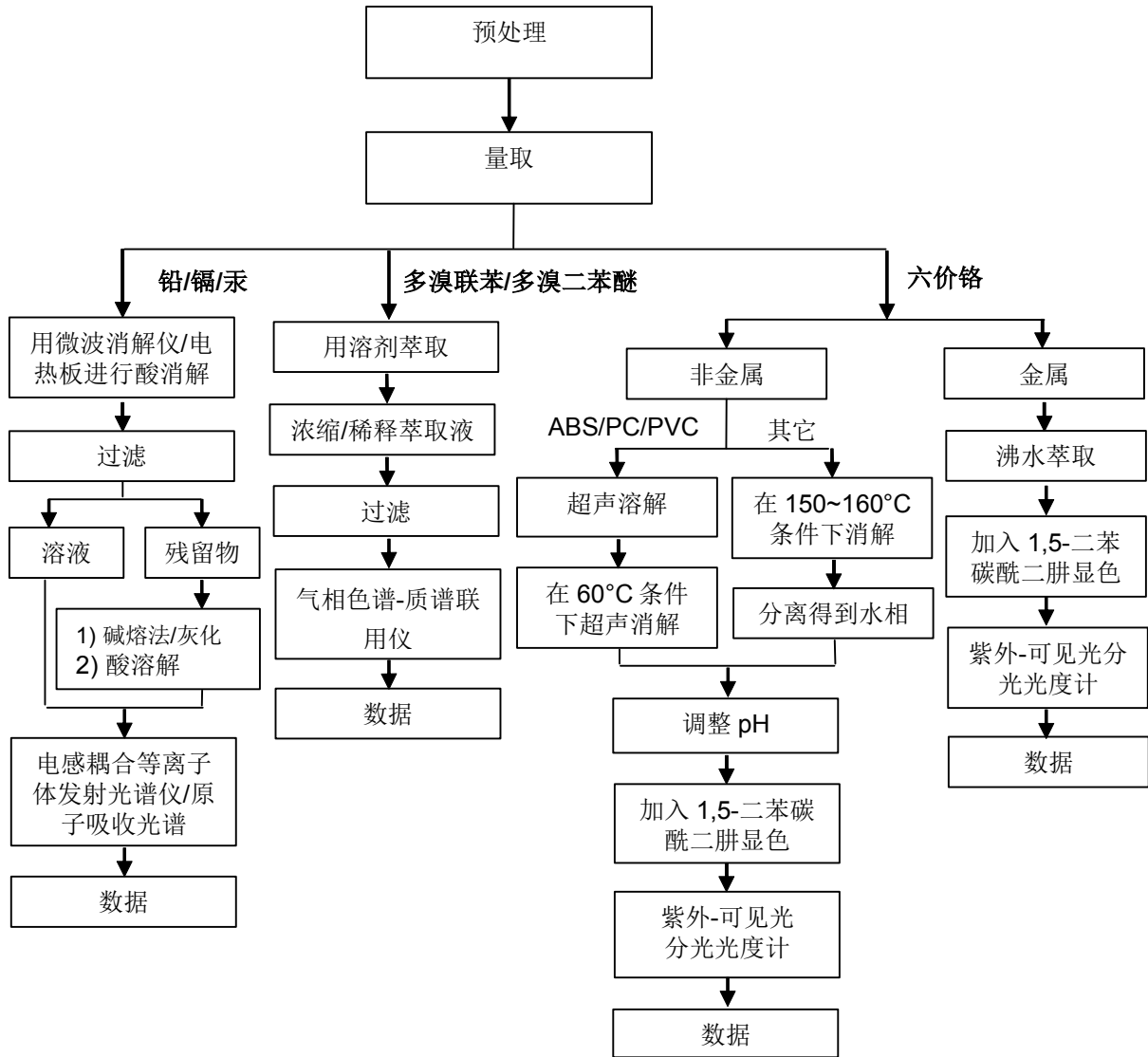

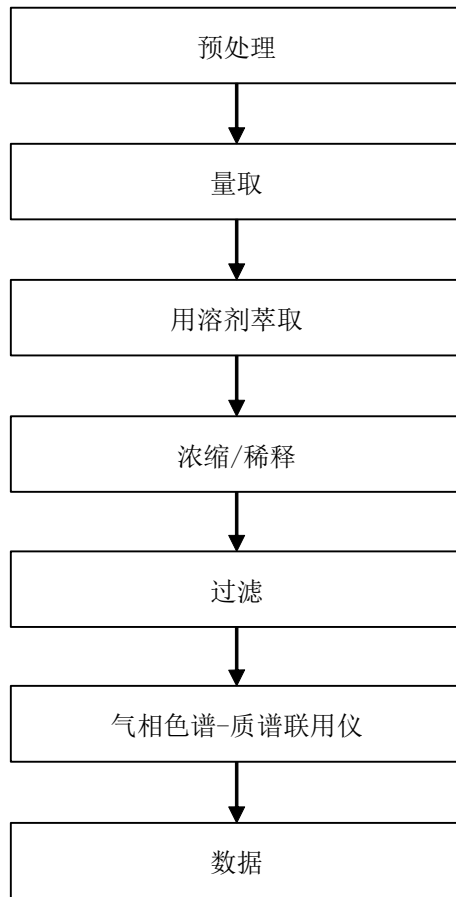

Phthalates 检测流程图

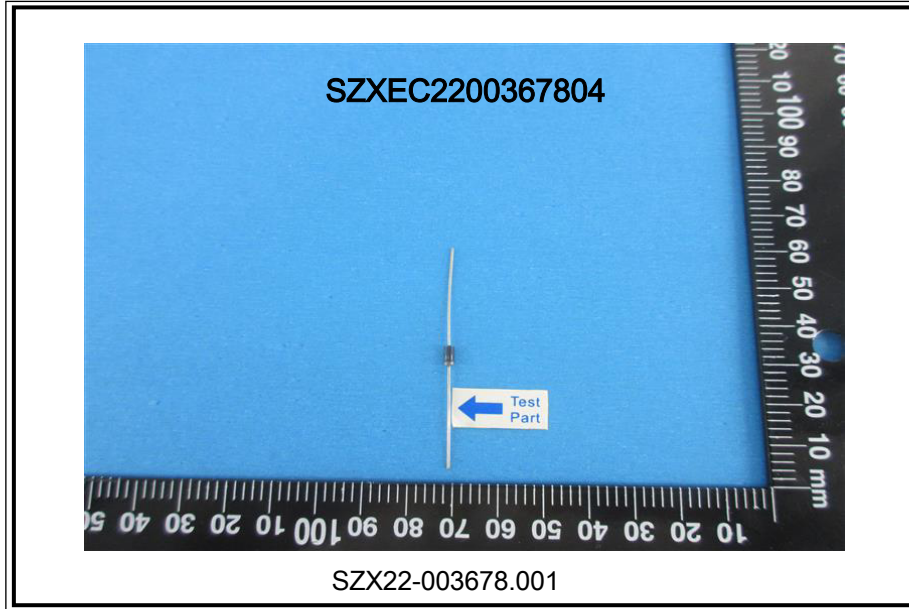
